GUIDED BY YOUNG PEOPLE'S INPUT FROM NOMINATION TO SELECTION, WE SUPPORT ORGANIZATIONS THAT ARE INFORMED OR LED BY YOUNG PEOPLE, ROOTED IN EQUITY AND INCLUSION, AND PROVIDE FREE, ACCESSIBLE MENTAL HEALTH RESOURCES.
