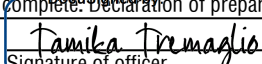
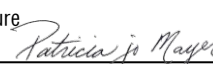

TEEN MENTAL HEALTH FIRST AID (TMHFA): IN 2020 AND 2021, WHEN TEEN MENTAL HEALTH CRISES SOARED DUE TO THE DEATH, TRAGEDY AND ISOLATION STEMMING FROM THE GLOBAL PANDEMIC, THE PROGRAM CONTINUED TO EXPAND. BORN THIS WAY FOUNDATION PARTNERED WITH THE NATIONAL COUNCIL FOR BEHAVIORAL HEALTH TO BRING TMHFA PROGRAMMING TO THE UNITED STATES.
